**PLAINTIFF’S UNOPPOSED MOTION FOR EXTENSION  
OF TIME TO FILE SETTLEMENT APPROVAL DOCUMENTS**

Chieftain Royalty Company (“Plaintiff”), pursuant to LCvR 7.1(i), files this *Unopposed Motion for Extension of Time to File Settlement Approval Documents* and respectfully show the Court as follows:

1. On December 17, 2018, the Court entered the *Order Granting Preliminary Approval of Class Action Settlement, Certifying the Class for Settlement Purposes, Approving Form and Manner of Notice, and Setting Date for Final Fairness Hearing* setting a number of deadlines, including moving for: (a) final approval of the Settlement pursuant to Federal Rule of Civil Procedure 23(e); (b) entry of a Judgment in substantially the same form as Exhibit 2 to Doc. 70; final approval of the Allocation Methodology and Plan of Allocation; and (d) attorneys’ fee, reimbursement of Litigation Expenses, and/or a Case Contribution Award. *See* Doc. No. 74, at ¶ 18.

2. The filing deadline for above documents is no later than 5:00 p.m. CT on February 8, 2019.

3. Plaintiff requests an extension of until 11:59 p.m. CT on February 8, 2019, within which to file the settlement approval documents.

4. There have been no previous requests for this deadline.

5. Plaintiffs' counsel has contacted counsel for Defendant and is authorized to state that Defendant does not object to the requested extension of time.

6. In compliance with LCvR 7.1(i), a proposed *Order* is being submitted in conjunction with this *Motion* for consideration by the Court.

### CONCLUSION

For the reasons stated above, Plaintiffs respectfully request that the Court grant this extension and enter the proposed *Order* reflecting the new deadline set forth herein.
